**The following items were approved during the open session of the May 20, 2024 Regular Board of Education Meeting:**

- A. Approved two (2) resident student requests to attend a non-resident school through open enrollment for the 2024-2025 school year.
- B. Approved the Land/Water Conservation Fund (LWCF) application resolution.
- C. Approved the 2024-2025 SOAR contract for \$26,767.00.
- D. Approved the The Lakes Community Health Center Dental Outreach Agreement for 2024-2025.
- E. Approved the 2024-2025 CESA #12 service contract for \$57,781.00.
- F. Approved the 2024-2025 Aspirus Rhinelander & Tomahawk Hospital and Clinic athletic training service agreement.
- G. Approved the Heartland Business Services Wireless System Upgrade for \$19,800.61.
- H. Approved resolution authorizing the transfer of funds, the establishment of an escrow account with respect to and the defeasance of certain of the general obligation refunding bonds, dated July 9, 2020.
